

**NORTH EAST TOWNSHIP SUPERVISORS
YEAR-END MEETING
TUESDAY, DECEMBER 23, 2025
10:00 AM**

Chairman Russ LaFuria called the meeting to order with the Pledge of Allegiance. Also, in attendance were Supervisors August Neff and Fredrick Shunk, Attorney Andy Schmidt and Secretary Erica Carlstrom.

Chairman Russ LaFuria asked for public comments or concerns and no responses were received. A motion from August Neff and the second from Russ LaFuria approved the minutes of the December 1, 2025 meeting as presented and was passed by unanimous vote. Bills for the period of December 1st through the 22nd were presented for approval and payment as follows:

Total approved by a motion from August Neff and the second from Fredrick Shunk was \$494,087.14 and passed by unanimous vote.

A motion from Fredrick Shunk and the second from August Neff gave final approval to the 2026 General Fund Budget in the amount of \$2,256,848.00 and passed by unanimous vote.

A motion from August Neff and the second from Russ LaFuria gave final approval to the 2026 State Liquid Fuels Budget in the amount of \$392,305.00 and passed by unanimous vote.

A motion from Fredrick Shunk and the second from August Neff gave final approval to the 2026 Water Fund Budget in the amount of \$1,394,650.00 and passed by unanimous vote.

A motion from August Neff and the second from Russ LaFuria gave final approval to the 2026 Sewer Fund Budget in the amount of \$1,987,385.00 and passed by unanimous vote.

A motion from Fredrick Shunk and the second from August Neff passed Resolution #2025-019, appropriating specific sums estimated to be required for the specific purposes of the municipal government for 2026. Passed by unanimous vote.

A motion from Fredrick Shunk and the second from August Neff passed Resolution #2025-020, fixing the tax rate for the Year 2026 as follows:

Tax Rate for General Purposes.....	1.04 mills.....	.104 cents.
Tax Rate for Library Purposes074 mills.....	.0074 cents.
Total	1.114 mills.....	.1114 cents.
Passed by unanimous vote. Noting, no tax increase for 2026.
