

NORTH EAST TOWNSHIP SUPERVISORS
MEETING
MONDAY, NOVEMBER 21, 2016
9:00 AM

Chairman August Neff called the meeting to order with the Pledge of Allegiance. Also in attendance Supervisors Fredrick Shunk and Robert Mazza, Attorney Robert Jeffery and Secretary Karen Ahlgrim. Members of the public included Kurt Lichtenfeld, Ann Kreider, Jim Williams, Teresa Sculley, Matt Putman, Bill Heald, and Julie Creed.

Chairman Neff asked for public comments or concerns and none were received. A motion from Fredrick Shunk and the second from Robert Mazza approved the minutes of the November 7, 2016 meeting as presented and passed by unanimous vote. Bills were presented for November 1st through November 20th, 2016 for approval and payment as follows:

Total approved by a motion from Fredrick Shunk and the second from Robert Mazza was \$143,343.98 and passed by unanimous vote.

Correspondence:

Supervisors acknowledged and read a request from Property Tax Collector Penny Luke, to keep her offices compensation at the current rate of 4% for the upcoming term 2018-2021. This rate applies to her rate collecting Township/Library and County taxes.

New Business:

A motion to accept and advertise the 2017 General Fund Proposed Budget in the amount of \$1,967,485.00 was received from Robert Mazza and the second from Fredrick Shunk and passed by unanimous vote. Mr. Putman asked if there was any special item causing the increased number over 2016, it was noted extra money was put in roads and repairs. No tax increase for 2017.

A motion to accept and advertise the 2017 State Liquid Fuels Proposed Budget in the amount of \$371,574.00 was received from Fredrick Shunk and the second from Robert Mazza and passed by unanimous vote.

A motion to accept and advertise the 2017 Water Fund Proposed Budget in the amount of \$1,200,850.00 was received from Robert Mazza and the second from Fredrick Shunk and passed by unanimous vote.

A motion to accept and advertise the 2017 Sewer Fund Proposed Budget in the amount of \$1,391,425.00 was received from Fredrick Shunk and the second from Robert Mazza and passed by unanimous vote.

August Neff noted that the handicap accessible trail at the Conservation Park is well under way, Robert Mazza asked what portion of the project is the Township's responsibility, August Neff noted that the Fish & Boat Commission are placing 6' of blacktop and we opted to add 2' more to that so that the trail will be 8' wide, we also did some grading, labor and equipment rental as in-kind contributions. The parking area was one-half the Fish & Boat and one-half the Township. There will be no fishing pier until spring 2017, and signage and an entrance to the trail added then also.

After announcements a motion to adjourn at 9:15 am was received from Robert Mazza and the second from Fredrick Shunk. Meeting adjourned.
