New Business:

North East School District, Maroon Road, would like to replot .03 acres of their parcel. The Baker's are buying the .03 from the school district. It will become integral with their parcel on Catawba Drive as it is in the Township with the rest of their property being in the Borough. A motion to approve and sign was made by August Neff and the second from Russ LaFuria. Passed by unanimous vote.

Supervisor August Neff discussed the Oshkosh's. Truck #9 which is used for plowing, upon inspection was discovered that the frame is cracked. The cost to fix the frame would be approximately \$36K. Neff discussed how he would like to take the 2 back up trucks that the Township currently has and work on both to get them ready for next season. He feels between both trucks it would cost around \$50K to have them road worthy. Gus stated his priority would be to get the 2004 Oshkosh fixed. Supervisor Russ LaFuria made a motion to approve \$25,000.00 for the '04 and we would see if we stayed within budget for that truck and if so then we could proceed with the tow truck Oshkosh. A second motion was received from Fredrick Shunk. All in favor.

Water/Sewer Supervisor Fredrick Shunk mentioned the Township is working on flushing hydrants within the Township. He also noted that the drilling for the sewer project on Route 5 is almost complete.
